Teachers do not do daily lesson plans. Instead, teachers develop a detailed course syllabus.

How are the needs assessed and met for IEP students? Creative Minds SpEd teacher provides support for students on IEPs.
Is curriculum state approved? Yes No Comments: School director reported that Creative Minds does not use a published curriculum. Teachers use the state grade level benchmarks to develop their own curriculum. Course syllabi indicate teacher uses Glencoe math textbooks.
In conversation with the staff at Creative Minds we asked how they were preparing for the new Common Core State Standards and the Smarter Balanced Assessment. We were surprised when they did not know about these new state requirements being implemented in the 2014-15 school year. They were not aware of the shifts in English Language Arts and Mathematics. We also explained the amount of staff developmented bethelmore had provided this year to prepare administrators and teaching staff for the CCSS implementation at the curricular adjustments the District was making. We gave them a quick overview of these changes, provided them with on-line resources, and emphasized the more rigorous requirements for high school graduation. We found the lack of awareness very concerning and believe that the school will be hard-pressed to get up to speed within the short amount of time they have left in the school year.

Students work mostly in the small group format but may choose to work by themselves. Students are cooperative within the small group setting. In general, students were engaged in the lesson.
What is the instructor's style of presentation? Varies. There tends to be an emphasis on oral instruction but teachers encourage students to engage in discussion of the materials. One group was working in the compulab on a report of their choice and students did have evidence of task completion.
