Alternative Education Programs**

The Board is dedicated to providing educational options for all students. It is recognized that there will be students in the district whose needs and interests are best served by participation in an alternative program.

"Alternative education program" means a school or separate class group designed to best serve students' educational needs and interests and assist students in achieving the academic standards of the school district and the state.

A list of alternative programs will be approved by the Board annually. Annual evaluation of all alternative programs will be made in accordance with Oregon Revised Statute (ORS) 336.655 and Oregon Administrative Rule (OAR) 581-022-2505. The superintendent will develop administrative regulations as necessary to evaluate the district's alternative education programs.

Alternative programs will consist of instruction or instruction combined with counseling. These programs may be public or private. A public and private alternative program shall be registered with the Oregon Department of Education. Alternative programs must meet all the requirements set forth in state law and rules, and federal law as applicable.

Students, upon approval from a parent or guardian, may be placed in an alternative education program if the district determines that the placement serves the student's educational needs and interests, and assists the student in achieving district and state academic content standards. Such placement must have the approval of the student's resident district and, as appropriate, the attending district. The parent, guardian or person in parental relationship is responsible for enrolling the student. The district will also consider and propose alternative education programs for students prior to expulsion or leaving school as required by law.

The district shall pay the actual cost of an alternative program cost or an amount equal to 80 percent of the district's estimated current year's average per-student net operating expenditure, whichever is less. The district is not obligated to provide or pay for transportation. The district will enter into a written contract for a district approved district approved private alternative education programs. As required by law

THIS AGREEMENT is made and entered into the 1st day of July, 2023 between the Springfield School District hereinafter referred to as District, and the Alternative Education Provider, hereinafter referred to as the Provider.

WHEREAS the District desires to contract for educational services to meet the learning needs of resident students in general education and special education programs identified by District procedures and with prior approval Provider shall comply with state requirements to provide alternative education services to District (district) students. ORS 336.631 and ORS 336.637

WHEREAS Provider will provide these educational services under the terms and conditions set out herein, and

It is the purpose of this agreement to identify the direct and/or related services to be provided through this agreement;

- 1. Providing there is sufficient space available, Provider will provide educational services for District students in the program or site indicated. The compensation for such services shall be at the rate as specified under section 7 of this agreement.
- 2. Provider reserves the right to make all final decisions concerning acceptance of students in the program.
- 3. At the time of referral, the District shall be responsible for informing Providers in writing of a student's at-risk status (discipline, suspension or expulsion for misconduct) as defined in ORS 339.250, ORS 339.240, ORS 339.250, & 339.260/OAR 581-021-0055, OAR 581-021-0065, OAR 581-021-0070.
- 4. The student's program will be individualized and reasonably designed for student success and growth due to their learning needs and circumstances.
- 5. Provider ensures they will meet the following conditions and criteria:
 - a) Provider shall be registered with the Oregon Department of Education as an approved Alternative Education program.
 - b) Provider shall carefully screen all staff members (whether paid or volunteer). Provider shall provide to District a list of all staff members and a memo explaining each staff member has successfully completed a criminal records

check. The list would be updated for each and every additional or replacement staff member during each Fiscal Year. Provider shall retain proof of record check for length of this contract.

- c) The provider shall supervise students (a) upon arrival at the school site, (b) during the school day, and (c) leaving the school site upon school day completion. Provider shall supervise each person who comes into contact with the students under this Agreement. The screening and direction shall assure that the individual is appropriate to be trusted with young persons. Provider shall assure that the location of its services is in an area where students and staff may be properly supervised. Each employee assigned under this Agreement by Provider shall be carefully instructed and supervised regarding the confidentiality of information learned about students and their families, and maintaining a professional relationship with students and their families by avoiding any behavior that undermines the professional character of that relationship.
- d) Contractor agrees to comply with all state statutes, rules and Standards. Contractor also agrees to comply with district policy, procedures and contract terms for placement of students. Non-compliance with an alternative education rule or statute may result in the termination of this contract. OAR 581-022-1350(4)(g)
- 6. The Provider shall comply with the Oregon Educational Reform Act by implementing all statewide testing and required work samples for eligible students. There is a shared responsibility between the Provider and the District for identifying students eligible for testing and retesting. The District requires that each district student complete the appropriate OAKS, PSAT, and ACT testing annually. The District and the Provider will identify contact persons to coordinate testing procedures (ORS329.485).
- 7. SPS shall pay the provider for the above-described services over the school year an amount of \$4,620 per student for each month during the 2023-24 school year or while the student is enrolled with the provider.
 - a) Additionally, SPS shall pay the provider for RN Planning & Delegation at a rate of \$70 per unit, and RN Coverage for LPN Absence at a rate of \$70 per unit.
- 8. This agreement shall be effective from the 1st day of July 2023 to the 30th day of June 2024. The terms of this agreement may be extended or amended as mutually agreed upon between the parties in writing. The District shall generate the renewal of the contracts annually.

- 9. Provider shall not in any manner (by express advocacy or other affirmative conduct) seek to compete with District for the attendance of students or engage in any conduct encouraging students eligible for attendance in schools of District to refuse attendance.
- 10. The District and the Provider acknowledge that no relationship is established by this contract beyond the scope of those rights and obligations specified herein The District exercises no control over the Provider program; nor is responsible for its acts, and assumes no specific responsibility to the Provider except for those specified under the terms of this agreement. Exceptions to this are as follows:
 - a) The District shall monitor for compliance for IDEA regulations.
 - b) The District shall evaluate alternative education services of the Provider as required by ODE OAR 581-022-1350(4) and ORS 336.615, 336.665
 - c) The Provider shall submit any other evaluation or report as required by state or Federal law.
- 11. In order to comply with SB 819 (abbreviated school day), the Provider must offer a full school day. If the school day is shorter than a full school day, for any individual student, the Provider must immediately inform the District's case manager. If applicable, the Provider will assist with complying with all aspects of SB 819, including a) obtaining consent for discussing abbreviated school day, b) obtaining consent for offering an abbreviated school day, c) fulfill all subsequent meeting timeline requirements, d) fulfill all obligations to obtain subsequent consent for abbreviated school day, e) fulfill the timely reporting requirements to the District to meet ODE deadlines.
- 12. If suit or action is brought for the purpose of enforcing the terms of this agreement, the prevailing party in such suit or action shall be entitled to attorney's fees and costs in said suit or action at trial or upon appeal.
- 13. HOLD HARMLESS AND INDEMNIFICATION: to the fullest extent of the law, Provider will defend, indemnify, hold harmless and reimburse District (including its officers, board members, agents and employees from all claims, demands, suits, actions, penalties, damage expenses for liability of any kind) including attorney's fees. To the extent that death or bodily injury to persons or damage to property arises out of the fault of the Provider, the Provider indemnity obligation exists only to the extent it contributed to or caused such damage, whether or not such are contributed to or caused in any part by District.

14. INSURANCE: Provider shall maintain in force for the duration of this agreement a Commercial General Liability Automobile Liability (owned, non-owned and hired) Insurance policy(s) written on an occurrence basis with limits not less than \$1,000,000 per occurrence and \$2,000,000 in the aggregate naming the District, its employees, officials, and agents as an additional insured as respects to work or services performed under this agreement. This insurance will be primary to any insurance the District may carry on its own. If the District requires Professional Liability coverage, the terms conditions, and limits must be approved by the District's Risk Manager. Evidence of the above coverage issued by a company satisfactory to the District must be provided to the District by way of a certificate of insurance before any work or services commence. A 30 day written notice of cancellation or material change in coverage clause shall be included. Failure to maintain the proper insurance shall be grounds for immediate termination of this contract. The District and Provider shall indemnify and hold harmless the other from all suits or actions of every nature and description brought forth on account of any damage, injury (including death), or loss which may have been caused or may have resulted from the other's performance of this agreement.

Workers' Compensation: Provider shall provide and maintain workers' compensation coverage for its employees, officers, agents, or partners as required by applicable workers' compensation laws. Provider shall provide a certificate of insurance to the District as evidence of coverage containing a 30-day notice of cancellation clause. No workers' compensation insurance shall be obtained by the District concerning the Contractor or any employees of the Contractor.

Equipment and Material: Provider shall be responsible for any loss, damage, or destruction of its own property, equipment, and materials used in connection with the work.

Subcontractors: Provider shall require all subcontractors to provide and maintain general liability, auto liability, professional liability (as applicable), and workers' compensation insurance with coverages equivalent to those required of District in this contract. Provider shall require certificates of insurance from all subcontractors as evidence of coverage.

Exception or Waivers: Any exception or waiver of these requirements shall be subject to review and approval from the District's Risk Manager.

15. The intent of this agreement is to hold harmless all current and previous contractors who have been compensated at a higher rate of pay. (This is referred to as the grandfather clause).

Initial Screening

- 1. A member of our administrative team will share the Circle of Friends School mission, eligibility criteria, review of our program design, anticipated classroom openings, and discussion of monthly costs. The screening will include a discussion about the youth/student, their current educational placement, and individualized needs.
- 2. Before a scheduled site visit, our team may make arrangements to visit the youth/student's current educational placement.
- 3. Once eligibility criteria, observations, and other considerations are satisfied, a site visit with the family, youth/student, and school district representative will be scheduled.

Eligibility Criteria

- 1. A youth/student who requires the use of specialized mobility or orthopedic devices to ambulate in their environment, tools to support fine motor skills, adaptive equipment that support daily living activities and adult dependency in order to be an active participant across all settings.
- 1. A youth/student who has complex communication needs associated with severe speech and physical disabilities and require the use of a modality other than natural speech as a primary communication mode to meet daily social and communication needs.
- 2. The youth/student's primary disability includes one or more of the following but not limited to:
 - Orthopedic impairment/physical disability
 - Visual impairment/low vision/blindness/cortical vision impairment
 - Deafness/hard of hearing, significant
 - Intellectual disability
 - Undiagnosed genetic disorders

We welcome and encourage diversity. Our services are available to all who need them, without regard to ethnic background, race, color, creed, sex, sexual orientation, socio-economic status, national origin, religion, or disability in compliance with ORS 659.850(1). Due to the design of our educational program, in order to fulfill our mission, we are unable to consider admission for a youth/student with the following characteristics or learning needs:

 Behaviors that are dangerous or behaviors that would significantly disrupt or otherwise impact participation of other student's learning, pose a threat to student's safety, and inhibit classroom operation.

Other considerations:

• Can Circle of Friends School educational or nursing staff appropriately meet the health, safety, and physical care needs of the youth/student throughout their school day?

- Is our program plan and the intentional goal development appropriate to meet the learning needs of this youth/student without significant alterations to our staffing and physical setting?
- Does the youth/student's family have a working relationship with their home school district and have informed the appropriate school district representatives of the interest in Circle of Friends School?
- Is funding available to cover the student's placement costs to Circle of Friends School through the youth/student's home school district or some other funding source?

Circle of Friends School Site visit:

- Family members and school district representatives will be asked to accompany the youth/student for a site visit during school hours to meet with our team to discuss educational needs and observe our program in action. Your youth/student may be encouraged to briefly participate and/or interact with our students and educational staff.
- The youth/student's current educational team and the Circle of Friends School team will determine the appropriate next steps before finalizing admission. An admission packet will be made available.

Admissions process:

- Complete admissions packet includes the following:
 - Admissions Disclosure Statement
 - Exchange of Information/ Release of Information form signed by parent or legal guardian
 - Copies of educational records and other relevant reports
 - Supplemental video recordings demonstrating how the youth/student interacts and communicates with others are optional.
- Admission and memorandum of agreement which includes placement fees between district and Circle of Friends contract required before attending.




